 The present petition is filed by the appellant in the forum seeking for removing of electrical poles & Transformer Centre just front of main Entry gate

Representation of Appellant

- Applicant, Deepaben S.Virwani has applied for electricity connection for her house to Rambag sub division, PGVCL Office Gandhidham.
- Applicant, Deepaben S. Virwani, in her complain state that she submine house map approved by GDA to Rambag sub division, PGVCL office where clearly showed that

the width of her house is 17 feet where as the front is fully covered with electric poles and D.P.

- Applicant plead to Rambag sub division, PGVCL office 1st-may 2022 planned of construction, after then regularly following up to remove four poles and transformer just in front of the main entry gate.
- Applicant further said that her site is under construction, so there is chance of fatal accident to labour and their kids, due to this construction got delayed.
- Applicant, also mention in her complain that she requested to Rambag subdivision in her letter dt.10/02/2023 to remove four poles and transformer just in front of the main entry gate, Which is very risky.
- Instead of help, she asked to pay estimate to remove the poles and D.P.
- In this regards, applicant request to CGRF to give justice and timely remove four poles including transformer D.P. just outside touched to her house gate and shift them to proper place and solve her problem.

Representation of PGVCL

PGVCL has received representation from CGRF Bhuj on dtd 03.05.2023 for complainant Smt. Deepaben Sunil Virwani having residential Address Duplex No 2 Plot No 301 ward 5 B Adipur & complain received physically in Rambaug Sdn on dtd 10.02.2023

As per sub division compliance regarding shifting of PGVCL electrical poles and transformer at location Duplex No 2 Plot No 301 ward 5-B Adipur survey work carried out and estimate Amounting Rs. 55447/- against SR No 16059348 has been issued to applicant on dtd 15.04.2023 per PGVCL rules and regulation Additionally estimate has to be paid on or before date 15.05.2023 otherwise further action will be taken in hand from this office end as per company norms.

Also notice has been issued to the applicant to adopt precautionary measures while working near the line, As per notice party should have to maintain safe distance from PGVCL network as per CEA regulation 2010.

As per Applicant complain of removal of 4 Nos of pole and transformer from the applicant location it actually does not exists in complainant property, It lies in the utility space provided by statuary body , Hence the removal of PGVCL Pole & Network existing in consumer premises is baseless, through if the party is facing any problem then as the estimate will be paid by the party shifting work will be initiated accordingly.

Forum finding

After learn from both party complainer & PGVCL it is clear that the PGVCL Network lies in the utility space provided by statuary body, and same are before the plot purchased by complainer hence if complainer facing any problem then as the estimate will be paid by the party shifting work will be initiated accordingly.

Order

PGVCL issue estimate for shifting of transformer Centre and 4 Nos Pole is as per rules however directed to PGVCL authority for re survey the site of complainer & If other possibilities or option for shifting of such transformer Centre and poles Estimate should be minimized if possible

We order accordingly.
