Sub: Ease of Doing Business – Business Reforms Action Plan – 2017 – Release of new electricity connections.

Respected Sir,

In view of the suggestions made in the EoD Business Reforms Action Plan-2017 and in pursuance with the approval of GUVNL Authorities, GUVNL has issued Circular as per reference 3. Now DIPP Department, GoI has directed to reduce 21 days period for releasing connection where RoW issue required to 15 days. In view of above, you are kindly requested to treat earlier Circular issued vide GUVNL letter No. GUVNL/Tech-2/EoD /720 dated 03.07.2017 as cancelled. The revised Circular is as under.

1) Timelines for release of Residential, Commercial & Industrial connection

Time line for releasing Residential, Commercial & Industrial connections (LT) shall be as under.

Activity	Time limit
Maximum Number of Days from the date of receipt of required deposits to complete application where no 'Right of Way'(RoW) is required i.e. connection is of 'A' Type	07 Days
Maximum Number of Days from the date of receipt of required deposits or date of submission of Electrical Inspector approval whichever is later to complete application where 'Right of Way'(RoW) is required i.e. connection is of B, C & D Type not involving any feeder bifurcation	15 Days

2) Timelines for release of HT Connection up to 150 KVA

Work Involved	Category	Timeline
Maximum Number of Days from the date of receipt of required deposits or date of submission of Electrical Inspector approval whichever is later to complete application where No work involved, only replacement of CTPT (for additional Load) or erection of only D.P. structure, extending HT line up to 1 span where no 'Right of Way'(RoW) is required	A	07 Days
Maximum Number of Days from the date of receipt of required deposits or date of submission of Electrical Inspector approval whichever is later to complete application where 'Right of Way'(RoW) is required and Erection of HT line by tapping existing feeder up to 300 meters	B	15 Days

You are requested to instruct the concern to take necessary actions accordingly for release of new electrical connections. Other guidelines circulated vide letters under reference 1 & 2 remains the same.
