Sub : Guideline required for releasing of AG connection to AG Co-operative Society by giving overriding priority :- Clarification thereof

Vide letter under reference at Sr No.1, you have sought some clarifications for the matter regarding releasing of AG Connection to AG Co-operative Society by giving overriding priority.

In this matter, point wise clarifications are as under.

Point No.1

- As per GUVNL Circular No. GUVNL/RE/SP. Priority/ 1048 dtd. 01.12.06, all norms of TATKAL for issue of estimate and application of Tariff are applied to this scheme. Therefore, the guideline is required for which type of TATKAL norms can be applied to this scheme i.e. Tatkal-2010 or Tatkal-2013 or Old Tatkal.
- Further clarification is also required for irrigation area for adoption of MIS i.e. (a) 50% irrigation area of land or 2 Acres whichever is higher. (b) 50% irrigation area of land or 2 hectores whichever is higher. (c) Entire Irrigation area

Clarifications


- Present norms of TATKAL Scheme, whatever in force, are applicable to give overriding priority to Registered Co-operative Irrigation Mandli / Society.
- At present norms of TATKAL Scheme -2013 are in force; so, as per Government GR dtd. 23.08.2013, DRIP irrigation should be for entire irrigation area of applicant's land.

Point No.2

- If norms of TATKAL 2013 scheme may be applied to this scheme, what will be the criteria for adoption of MIS i.e. whether MIS is to be adopted as per HP base according to GGRC guideline or Farmers can choose MIS as per their willingness.

Clarifications

- At present norms of TATKAL Scheme -2013 is in force; So, as per Government GR dtd. 23.08.2013,
 - All applicants have to adopt DRIP Irrigation and should give consent for the same. DRIP irrigation should be for entire irrigation area of applicant's land (i.e. Particular L.S. No/ Block No. where connection is demanded)
 - Sprinkler System should be allowed only after review of crop pattern of a particular area. GGRC and concerned DISCOM have to identify such area / crop pattern and should inform the applicant accordingly.
