Hon'ble GERC has through letter dated 24th June, 2014 approved and revised the service connection charges. Revised service connection charges payable by the applicant/ consumers for new connection/ additional load/ shifting of connection are applicable for the applications received on or after 1st July, 2014 and are as under.

Schedule of charges to be recovered as per GERC approval are as under:

1	Upto 2kW	Rs.3500.00
2	Above 2 kW and up to 6 kW	Rs.6500.00
3	Above 6 kW and up to 12 kW	Rs.12000.00
4	Above 12 kW and up to 20 kW	Rs.21000.00
5	Above 20 kW and up to 40 kW	Rs. 21000 + Rs. 1100 per KW
6	Above 40 kW and up to 60 kW	
7	Above 60 kW up to 80 kW	
8	Above 80 kW up to 100 kW	


- e. g. If consumer applies for 25 KW Load demand, the charges would be
 $Rs. 21000 + 5 \times 1100 = Rs 26,500/-$

Following points are to be taken care of while considering the charges.

- While releasing connections under Agri – Tatakal, Green House and Schemes approved by the Grant from State Government/ Central Government, the charges from the applicants are to be recovered as per the norms approved under respective scheme.

- Application for single phase lighting connection upto 3 KW is to be entertained in agriculture land including the cases, where agriculture connection does not exist in the same survey number. However, in such cases, it is allowed to recover actual cost as per latest cost data subject to maximum amount of Rs. 1.00 Lakh.
- In case of Infrastructure Development for Housing Colony/ Industrial Estate/ Street Light network etc., Discom may create Distribution Network on its own, where if there is any potential development in that area and as such the Discoms need not create network where there is no consumer to be supplied power and recovery for individual application should be made according to the service line charges on "per KW basis" approved by the Commission.
- Revised charges shall be in force till any further revision.

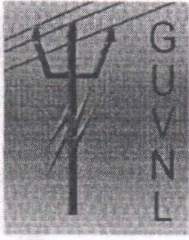

With reference to our proposal submitted to the GERC, vide letter under reference for revision of service connection charges and subsequent correspondence and discussions in various meetings, the Hon. Commission vide letter under ref (2) has approved revision in service connection charges payable by the applicants/consumers, for new connection/additional load/shifting of connection, as under.



The following points are to be taken care of while considering the charges.

- While releasing connections under Agri-Tatkal, Green House and Schemes approved by the Grant from State Govt./ Central Govt., the charges from the applicants are to be recovered as per the norms approved under respective scheme.
- DISCOMs shall entertain single phase lighting connection upto 3KW in agriculture land including the cases, where agriculture connection does not exist in the same survey number. However, in such cases, DISCOMs are allowed to recover actual cost as per the latest cost data subject to maximum amount of Rs.1.00 lakh.
- In case of Infrastructure Development for Housing Colony/Industrial Estate/Street Light Network etc, the DISCOMs may create Distribution Network on its own, where if there is any potential development in that area and as such the DISCOMs need not create network where there is no consumer to be supplied power and recovery for individual application should be made according to the service line charges on "per KW basis" approved by the Commission.
- The revised charges shall be effective for the applications received on or after 1st July 2014, and will continue to remain in force till any further revision.

It is requested to issue suitable instructions to all the field offices to recover revised charges for the new connection/additional load/ shifting of the connection, as approved by the Hon. Commission.

With reference to your proposal submitted vide letter dated 14th February, 2013 for the revision of service line charges payable by applicant/consumers for new connection/additional load/shifting of connection. The issue was discussed in various meetings and accordingly the Commission has approved Service Connection Charges as indicated below :


In your proposal you have submitted that in case of Single Phase Lighting connection in agriculture land shall be allowed with load limit of not more than 3 KW due to technical constraint of SDT and within same survey number where Agriculture Connection exists. However, the Commission directs that DISCOMs shall entertain all such applications including the cases where the agriculture connection does not exist in the same survey number. However, in such cases DISCOMs are allowed to recover actual cost as per latest cost data subject to maximum amount of Rs. 1 lakh.

While, in case of Infrastructure Development for Housing Colony / Industrial Estate / Street Light Network etc, the Commission has already given direction vide letter no. GERC/TECH/2014/1193 dated 3rd June, 2014 that the licensee may create Distribution Network on its own where if there is any potential development in that area and as such the licensee need not create network where there is no consumer to be supplied power and recovery for individual application should be made according to the service line charges on "per KW basis" approved by the Commission.

Kindly direct all the field offices to levy the revised charges for new connection/additional load/shifting of connection as approved above. The revised charges shall be effective for the applications received on or after 1st July, 2014 and will continue in remain force till any further revision.
