- In case of cash payment (up to Rs.10,000/-), the scan copy of cash receipt have to be upload in preliminary stage.

#### Payment of Earnest Money Deposit (EMD):-

- Payment of Earnest Money Deposit (EMD) can be accepted by RTGS/NEFT/online.
- In case of cash payment (up to Rs.10,000/-), the scan copy of cash receipt have to be upload in preliminary stage.
